

Terms and Conditions

1. Acceptance of Terms

- By accessing or using Margaux Zeitoun Experiences' services or website, you agree to be bound by these Terms and Conditions.
- If you do not agree to any part of these terms, you should not proceed with booking or using the services.
- These Terms and Conditions are subject to periodic updates, and continued use of the services constitutes acceptance of any changes.

2. Consulting and Travel Planning Services

- Margaux Zeitoun Experiences acts solely as an advisor and travel planner. My services include research, itinerary design, proposals, and recommendations based on your itinerary, my expertise and tools available.
- My services **do not** include the execution of bookings all bookings must be made by the client, unless the **Booking Assistance Add-On** is selected.
- If you choose the **Booking Assistance Add-On**, a separate waiver will clarify which bookings Margaux Zeitoun Experiences is responsible for. For example, you may opt for assistance only with transportation bookings.
- If you choose the **Booking Assistance Add-On**, please note that the tours and excursions booked by Margaux Zeitoun Experiences are **third-party services**. Margaux Zeitoun Experiences does not control, own, or operate these services. You are subject to the supplier's terms and refund policies.
 - If a tour or excursion is canceled or not performed as contracted, Margaux Zeitoun Experiences may attempt to make new arrangements but is **not obligated** to do so.
 Refunds should be sought directly from the supplier.
- Margaux Zeitoun Experiences is not responsible for executing or guaranteeing the services provided by third-party suppliers.
- Margaux Zeitoun Experiences is not liable for any unavailability, price changes, or quality issues related to third-party services, nor for cancellations by the client or service providers.
- Itineraries and proposals are indicative and dependent on external factors such as weather, local conditions, transportation, and the client's pace during travel. Margaux Zeitoun Experiences is **not** responsible if the agreed itinerary cannot be fully executed due to unforeseen circumstances, including but not limited to:

- Clients are strongly advised to verify all documentation and requirements independently.

4. Delivery Timelines

- Clients must submit a fully completed detailed questionnaire or book a "consultation call" to initiate the planning process.
- **Your first travel proposal** will be delivered within 14 days after receiving your completed questionnaire. For trips lasting more than 10 days, the timeframe extends to 21 days, unless otherwise agreed based on the complexity and timing of the project.
- The timeline for delivering the final PDF will be discussed on a case-by-case basis, and will depend on several factors, including your travel dates, the advance notice provided by the client, the trip's complexity, the number of revisions made to the initial proposals, and the time required by the client to complete all necessary bookings.
- Booking Period: To ensure the best prices and availability, we recommend confirming and booking your transportation, accommodations, and activities within 14 days of receiving your travel proposal. This also helps avoid additional fees for new searches or revisions requested after the initial proposal.

5. Payment Terms

- **Accepted Payment Methods**: Payments can be made via credit card, cash, Zelle, or Venmo.
- Full Payment Required: Payment is required in full at the time of booking via credit card.
- **Payment in Installments**: If paying by cash (Zelle, Venmo or cash), installment payments are available with no additional fees. However, full payment must be received by the applicable due date.
- **Late Payments**: If payment is not received in full by the applicable due date, reservations will be subject to cancellation, and any deposits paid will be forfeited.
- **Third-Party Supplier Terms**: Unless otherwise defined during the reservation process, final payment is due prior to departure or consumption, according to the terms and conditions of third-party suppliers (airlines, hotels, cruise lines, transfer companies, etc.). If full payment is not received by the applicable due date, reservations are subject to cancellation, and deposits shall be forfeited.
 - Cancellation Penalties: Cancellation penalties, as advised by third-party suppliers, will be provided upon booking confirmation. Please contact the supplier for clarification if any penalties are unclear.
 - Airline Reservations: Airline reservations are not included in your travel plan. It is the client's responsibility to make appropriate air arrangements. Margaux Zeitoun

Experiences is not responsible for air or ground schedule changes. Check-in times are also the client's responsibility.

6. Refund Policy

- **No Refunds**: Once a booking is made and paid for, there are **no refunds**. All bookings are personalized and cannot be reused for another client.
